Our organisation has been duly registered under _____ (Name of Act/Legislation under which the organisation is registered) and possesses a valid MoU with KVIC for Trade/Sale/Marketing of Khadi and Khadi products.

Our institution / organisation produces / trades / sells (whichever is applicable) khadi and khadi products i.e. hand spun hand woven and of natural fibre as defined in the KVIC Act.

Our Institution / organisation intend to trade / sell khadi and khadi products exclusively procured from Certified Khadi Institutions or KVIC. Such khadi institution should have obtained "khadi mark" issued under these regulations.

Khadi Mark Regulation 2013 has come into force from 2nd October 2013. Under the Act, no person or institution shall produce or sell or otherwise trade in Khadi or Khadi products in any form or manner without obtaining a Khadi Mark Certificate.


Similarly, no textiles shall be sold or traded as Khadi or Khadi product in any form or manner without it obtaining and bearing a Khadi Mark.

- These Khadi Mark labels and tags will only be used on genuine khadi and khadi products made of cotton, wool, silk or mixture of these khadi vastra i.e. hand-spun and hand woven fabric.

I/We will be solely responsible for the usage of Khadi Mark labels and tags only on genuine Khadi and khadi products as specified under the Regulations. Any violation of the same can draw appropriate legal actions against me/us.

I/We declare that the information given above is true and will be adhered to strictly. I/We will be solely responsible for any violation of the same that may entail legal action against me/us.
